



Valves for Compliance with The American Iron and Steel (AIS) Act

DeZURIK, your trusted source for quality valves, is committed to delivering products that comply with all AIS provisions. DeZURIK, APCO, Hilton and Willamette valves can be specified to meet provisions of H.R. 3547, the Consolidated Appropriations Act, for projects involving Clean Water State Revolving Funds (CWSRF) or Drinking Water State Revolving Funds (DWSRF). This requirement applies to projects for the construction, alteration, maintenance, or repair of a public water system or treatment works.



DeZURIK has close relationships with a network of US-based vendors throughout our supply chain that provide AIS compliant castings and components. DeZURIK products available to meet AIS provisions include:

DeZURIK's AIS designation must be specified in the order code at the time of quotation and ordering to ensure AIS compliance is maintained throughout the manufacturing process. When AIS valve products are ordered, DeZURIK will provide a certification letter that meets EPA documentation requirements.



DeZURIK has a large supply of valves that meet AIS requirements in our factory and representative stocking programs.

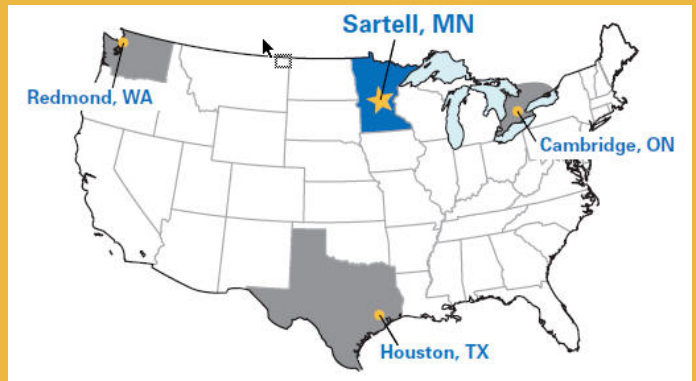
On October 23, 2018, the President signed the "America's Water Infrastructure Act of 2018" (AWIA), which includes several updates and revisions to the Safe Drinking Water Act (SDWA), including the Drinking Water State Revolving Fund (DWSRF) provisions. Section 2022 of AWIA amended Section 1452(a)(4)(A) of SDWA to extend the requirement for the use of American Iron and Steel (AIS) products in projects receiving financial assistance from the DWSRF during fiscal years 2019 through 2023.
